

**FOX CITIES AMATEUR RADIO CLUB  
BY-LAWS**

(Revision of the February 1986 BY-LAWS)  
**APRIL 1987**

(The Fox Cities Amateur Radio Club was established on October 21, 1985. The Neenah-Menasha Amateur Radio Club membership voted on that date to change the name of the club and to revise the constitution to better represent the Amateur Radio Community of this local area).

**ORGANIZATION AND PURPOSE**

- A. THE NAME OF THE ORGANIZATION SHALL BE: "FOX CITIES AMATEUR RADIO CLUB."
- B. IT SHALL NOT BE INCORPORATED.
- C. THE PURPOSE OF THE CLUB SHALL BE TO: (1) PROMOTE GOOD OPERATING PROCEDURES, EXPERIMENTATION AND ACTIVITIES ON ALL AMATEUR RADIO BANDS (2) PROMOTE AND ENHANCE AMATEUR RADIO AS A HOBBY.
- D. THE CLUB SHALL OPERATE AS A NONPROFIT ORGANIZATION AND RAISE FUNDS ONLY FOR THE NECESSITIES OF CLUB PROMOTION AND ENHANCEMENT.

**ARTICLE I**

**(MEMBERSHIP)**

SECTION 1: ELIGIBILITY. ALL PERSONS INTERESTED IN AMATEUR RADIO SHALL BE ELIGIBLE FOR MEMBERSHIP.

SECTION 2: CLASSES OF MEMBERSHIP. THE MEMBERSHIP OF THE CLUB SHALL BE DIVIDED AS FOLLOWS: FULL, ASSOCIATE, HONORARY, FAMILY, STUDENT, AND RETIRED.

FULL MEMBERSHIP: SHALL HAVE VOTING PRIVILEGES AND SUCH MEMBERSHIP SHALL BE RESTRICTED TO CURRENTLY LICENSED AMATEUR RADIO OPERATORS.

ASSOCIATE MEMBERSHIP: SHALL HAVE ALL MEMBERSHIP PRIVILEGES WITH THE EXCEPTION OF VOTING.

HONORARY MEMBERSHIP: IS GRANTED ONLY BY A VOTE OF THE MEMBERSHIP. FULL PRIVILEGES.

FAMILY MEMBERSHIP: IS EXTENDED TO INCLUDED

## ARTICLE II

### (MEETINGS OF MEMBERS)

- SECTION 1: REGULAR MEETINGS.** REGULAR MEETINGS OF THE MEMBERSHIP SHALL BE HELD THE THIRD MONDAY OF THE MONTH, AT A LOCATION DESIGNATED BY THE BOARD (DATE AND LOCATION MAY BE CHANGED BY THE BOARD OF DIRECTORS WITH ADVANCED NOTICE TO THE MEMBERSHIP). THE REGULAR MEETINGS AND/OR CHANGES SHALL BE ANNOUNCED IN THE CLUB NEWSLETTER.
- SECTION 2: ANNUAL MEETING.** THE ANNUAL MEETING FOR THE PURPOSE OF ELECTION OF DIRECTORS, TO RECEIVE REPORTS OF COMMITTEES ON ACTIVITIES AND ON FINANCES, AND TO TRANSACT OTHER NECESSARY CLUB BUSINESS SHALL BE HELD AT A PLACE DESIGNATED BY THE BOARD OF DIRECTORS DURING THE MONTH OF MAY EACH YEAR.
- SECTION 3: SPECIAL MEETINGS.** SPECIAL MEETINGS OF THE MEMBERS MAY BE CALLED BY THE PRESIDENT OR THE BOARD OF DIRECTORS AND SHALL ALWAYS BE CALLED BY THE PRESIDENT UPON THE WRITTEN REQUEST OF TEN MEMBERS OF THE CLUB ENTITLED TO VOTE AT SUCH SPECIAL MEETINGS.
- SECTION 4: QUORUM.** AT ANY AND ALL MEETINGS OF THE CLUB, 25 PERCENT OF THE VOTING MEMBERSHIP SHALL CONSTITUTE A QUORUM FOR THE TRANSACTION OF BUSINESS. WHENEVER A QUORUM IS NOT PRESENT THE PRESIDENT OR OTHER PRESIDING OFFICER MAY ADJOURN THE MEETING TO A FUTURE DATE WITHOUT FURTHER NOTICE. A MAJORITY OF THE VOTES ENTITLED TO BE CAST BY THE MEMBERS PRESENT IN PERSON AT A MEETING AT WHICH A QUORUM

## ARTICLE IV

### (DUES)

**SECTION 1: DUES.** REGULAR ANNUAL DUES OF EACH MEMBER SHALL BE AS FOLLOWS:

**FULL MEMBERSHIP:** \$10.00 PER YEAR - LICENSED MEMBER  
(ONE PER FAMILY)

**ASSOCIATE MEMBERSHIP:** \$10.00 PER YEAR

**HONORARY MEMBERSHIP:** NO CHARGE AND ALL PRIVILEGES

**FAMILY MEMBERSHIP:** \$2.00 PER EACH ADDITIONAL FAMILY MEMBER  
RESIDING AT THE SAME ADDRESS.

**STUDENT MEMBERSHIP:** \$5.00 PER YEAR (FULL TIME STUDENT)

**RETIRED MEMBERSHIP:** \$5.00 PER YEAR

DUES SHALL BE USED FOR THE PURPOSE OF PROVIDING FUNDS FOR CURRENT EXPENSES. DUES ARE DUE AND PAYABLE ON THE MONTH OF INITIAL MEMBERSHIP EACH YEAR. NON-PAYMENT OF DUES OR ASSESSMENTS SHALL BE CAUSE FOR REMOVAL FROM MEMBERSHIP WITHIN THE DISCRETION OF THE BOARD OF DIRECTORS. DUES ARE PROVIDED WITH A TWO MONTH GRACE PERIOD. RE-NEWAL REMINDERS ARE NOT PROVIDED.

**SECTION 2: INDEBTEDNESS.** THE CLUB SHALL NOT OBLIGATE ITSELF TO ANY FINANCIAL INDEBTEDNESS.

## ARTICLE V

### (OFFICERS)

**SECTION 1: PRESIDENT.** THE PRESIDENT SHALL PRESIDE AT ALL MEETINGS OF THE MEMBERS AND BOARD OF DIRECTORS AND CONDUCT THE SAME ACCORDING TO THE BY-LAWS. HE/SHE MAY SET UP VARIOUS COMMITTEES SUCH AS TVI/RFI, PUBLICITY, NOMINATING, ETC.

**SECTION 2: VICE PRESIDENT.** THE VICE PRESIDENT SHALL ASSUME ALL THE DUTIES OF THE PRESIDENT IN THE ABSENCE OF THE LATTER. HE/SHE SHALL ALSO ASSUME THE DUTIES
